# MINORITY **CLERKSHIP** PROGRAM



The Columbus Bar Association's Minority Clerkship Program (MCP) was established in 1987 and is a collaboration of the CBA, The Ohio State University Moritz College of Law, and Capital University Law School.

### **EMPLOYER INFORMATION**

The program's immediate goal is to provide legal experience and education for law students who are underrepresented in the legal community through summer placement at local law firms, government agencies and corporate offices. Some examples of underrepresented groups include but are not limited to individuals from disadvantaged backgrounds, individuals with disabilities, individuals from the LGBTQIA+ community, individuals who are first generation higher education students, and individuals who grew up in geographically disadvantaged communities or regions. This opportunity is open to all regardless of race or ethnicity. The program focuses on arranging clerkship positions for first- and second-year students.

To participate in the clerkship program, first- and second-year students from The Ohio State University Moritz College of Law and Capital University Law School are evaluated by potential employers on the basis of their writing, interview skills, and academic profile.
